



Shiatsu Pro - Membership Plan

Shiatsu Pro is proud to announce our membership program. In the simplest of terms our membership program is designed for those looking for an "excuse" to get a massage at least once a month.

Membership options:

_____ **\$59.90/month** for a **60 minutes** massage session for a period of **12 months**. For the initial term, you agree to pay Shiatsu Pro dues of \$718.80 (\$1,080.00 value). The amount is payable in monthly installments of \$59.90.

_____ **\$66.90/month** for a **60 minutes** massage session for a period of **6 months**. For the initial term, you agree to pay Shiatsu Pro dues of \$401.40 (\$540.00 value). The amount is payable in monthly installments of \$66.90.

_____ **\$89.90/month** for a **90 minutes** massage session for a period of **12 months**. For the initial term, you agree to pay Shiatsu Pro dues of \$1,078.80 (\$1,440.00 value). The amount is payable in monthly installments of \$89.90.

_____ **\$94.90/month** for a **90 minutes** massage session for a period of **6 months**. For the initial term, you agree to pay Shiatsu Pro dues of \$569.40 (\$720.00 value). The amount is payable in monthly installments of \$94.90.

- No sign up fees.
- A 60 minutes session consists of a 55-minute massage and time for consultation and dressing.
- A 90 minutes session consists of an 85-minute massage and time for consultation and dressing.
- By agreeing to this contract offered by Shiatsu Pro, the member acquires the rights to massage services in accordance with the terms of this agreement for the period of either 12 (twelve) or 6 (six) months, initial term.
- Members must be at least 18 years of age.
- At any time after the initial term, Shiatsu Pro may increase your membership dues by giving you at least 30 days written notice of the increase. Your obligation to pay membership dues is not dependent on your actual use of services by Shiatsu Pro.
- Services must be used within the month of payment. We allow two 'rollover' sessions during the initial term of 12 (twelve months) and one 'rollover' session during the initial term of 6 (six) months.
- Billing Authorization: You hereby authorize Shiatsu Pro, to bill your credit card on the 1st of each month in payment of your membership dues one time monthly according to the option selected above.
- This action will be taken beginning upon signing and agreeing to these terms and continues until contract ends by your written notice.
- If your credit card payment is declined for any reason, you will be liable for an additional \$30 reprocessing fee.
- Renewal and Cancellation of Membership. After the initial term, your membership will automatically be continued on a month-to-month basis. You may cancel your membership at any time after the "initial term" by giving Shiatsu Pro 30 days' advance notice of cancellation. Notice of cancellation must be in writing and, or by email. Emails should be sent directly to avi@shiatsupro.net with a confirm receipt. Shiatsu Pro will not provide retroactive refunds for pass holders who have failed to give 30 days' written notification.
- Termination/Temporary Freeze: Shiatsu Pro reserves the right to terminate your membership immediately if you fail to comply with the clinic's rules and regulations, if you engage in other

conduct that is detrimental to the health or safety of the staff, other members, or guests, or if you fail to pay the membership dues or other amounts that you owe to Shiatsu Pro. Upon termination or cancellation of your membership, you will be required to remain liable for any outstanding dues or other charges owed by you.

- a. Permanent Medical Disability: In the event that you are permanently unable to receive bodywork or any of the therapy services set forth in this agreement due to a medically documented condition, Shiatsu pro will require a signed letter from your physician detailing the medical reason for cancellation of the Agreement. No retroactive medical refunds will be issued.
- b. Temporary Medical Disability: In the event that you are temporarily unable to receive bodywork or therapeutic services set forth in this agreement due to a medically documented condition, Shiatsu Pro will require a signed letter from your physician detailing the medical reason for absence and expected duration of absence. Members must give shiatsu Pro the physician's letter within thirty (30) days of diagnosis to be granted the temporary commitment freeze. This freeze will be for a maximum of 3 months. Additional physician documentation will be required to extend the freeze period. The membership will be reactivated with written medical clearance. No retroactive medical refunds will be issued.
- c. If, during the initial term, you become disabled for a period longer than three months, you may extend your membership for a period equal to the duration of your disability. To qualify for the extension, your disability must be confirmed by a physician.
- Assignment and Transfer. Membership is nontransferable and any outstanding account credit may not be transferred or redeemed for gift certificates, retail purchases or cash. Members may transfer two sessions per term of agreement to another person.
- Clinic Liability Release. By signing this Agreement, I agree that Shiatsu Pro is in no way responsible for the safekeeping of my personal belongings while I'm in a massage session. I understand that massages may be physically strenuous and I voluntarily agree to receive a massage with full knowledge that there is risk of personal injury, or death. I agree that neither I, my heirs, assigns or legal representatives will sue or make any other claims of any kind whatsoever against shiatsu Pro or its members for any personal injury, property damage/loss, or wrongful death, whether caused by negligence or otherwise.

Member Referral Program

- You are our best source of referrals. To show our appreciation, when you introduce a new client that purchases a membership to Shiatsu Pro in the first 60 days of your membership, you'll receive a one-hour complimentary massage session. If you introduce a new client that purchases a membership to Shiatsu Pro after your initial 60 days, you'll receive a 30 minutes complimentary massage session.

Guest Visitation Privileges

- Share the experience of Shiatsu Pro with a friend or family member. As long as your membership is active and current, you may bring in a guest for a massage at the membership rate. You are welcome to bring in as many new guests as you like, however, you may not bring in the same guest more than once.

Member's benefits

- Members will enjoy a 10% discount of the membership price for any additional massage sessions given during the term of the agreement. This benefit is awarded for members only.
